24-07 The application of Chris Mendel, Executive Director of Pennypack Ecological Restoration Trust, 2955 Edge Hill Road, Huntingdon Valley, PA 19006 who seeks relief from the terms of the Zoning Ordinance of Lower Moreland Township to allow two (2) signs at 24 square feet where 4 foot is allowed and to install two (2) signs on each parcel where only one (1) is allowed. The parcels are 410008892004 and 410008878009, vacant land on Terwood Road with the closest intersection of Inverness Lane.
